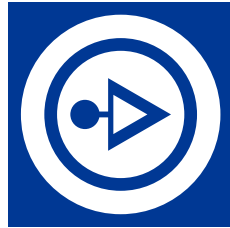

FIRST AID

IF IN EYES - Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses if present, after the first 5 minutes, then continue rinsing eye. Have the product container with you when calling a poison control center or doctor, or going for treatment.

IF ON SKIN OR CLOTHING -Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes.

IF INHALED - Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably mouth to mouth if possible.

IF SWALLOWED - Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control center or doctor. Do not give anything by mouth to an unconscious person.

PERSONAL PROTECTIVE EQUIPMENT (PPE)

Always refer to the label of the pesticide(s) in the tank mix and follow the most restrictive requirements. Follow manufacturer's instructions for cleaning / maintaining PPE. If no such instructions for washables exist, use detergent and hot water. Keep and wash PPE separately from other laundry.

PRODUCT INFORMATION

CLEARVIEW is safe to be used on applications on all crops including: vegetable crops, row crops, field crops, trees, vines, ornamentals, lawns, and garden landscaping in conjunction with pesticides and fertilizers that are applied to the soil. *CLEARVIEW* improves the compatibility of fertilizer blends and can also increase deposition of the final tank mixture. *CLEARVIEW* is a versatile product, compatible with most fertilizers (including acidic fertilizers), fungicides, herbicides, insecticides and plant growth regulators. The versatility of *CLEARVIEW* allows it to be used in combinations for in-furrow, fertigation, soil and/or foliar applications.

DIRECTIONS FOR USE

MIXING - Blend *CLEARVIEW* thoroughly in sufficient water or fertilizers to ensure adequate coverage.

SOIL APPLICATION: For best results, apply 12-32 ounces of *CLEARVIEW* per acre diluted in 5 gallons of water. Apply at planting with or without starter fertilizer. Application can be in-furrow or through any irrigation system.

FOLIAR APPLICATION: Dilute 4-16 ounces of *CLEARVIEW* per acre in 5 gallons of water and apply with or without fertilizers during plant growth and development. SAFE WITH ALL GLYPHOSATE FORMULATIONS FOR APPLICATION TO GLYPHOSATE TOLERANT CROPS.

STORAGE AND DISPOSAL

STORAGE: Store product in original container only, away from other pesticides, fertilizers, food or feed. Keep this container closed when not in use and take care to prevent any water from being introduced to the contents of this container. Avoid storage below 32 °F. If stored below 32 °F, allow product to warm to a liquid state before use.

DISPOSAL: Do not contaminate water, food or feed by storage or disposal. Triple rinse empty container and offer for recycling/reconditioning or dispose of in an approved sanitary landfill. DO NOT REUSE EMPTY CONTAINER FOR ANY PURPOSE.
