FIRST AID

PRODUCT INFORMATION

ENVELOP is an effective compatibility agent that helps to bring pesticide mixtures and fertilizer-pesticide tank mixes together to improve the stability and uniformity of their application. **ENVELOP** is most effective when added **before** incompatibilities occur. Initially, lower rates are suggested to help prevent the development of incompatibilities between active ingredients and fertilizers. **ENVELOP** may be useful to reverse incompatibilities but generally will require higher rates.

DIRECTIONS FOR USE

Tank mixtures should only be applied within the label recommendations of every product in the tank mixture. If the active ingredient label does not specify the use of a compatibility agent, follow the directions below. Use only if a compatibility agent is allowed or not excluded on the label. **ENVELOP** lowers the pH of the solution and is completely soluble in most liquid fertilizers.

NOTE: Consult pesticide labels for their specific use directions in liquid fertilizers. If the user does not have experience with the mixture being applied, perform a jar test using the order and amounts in the mixture and perform a phytotoxicity test to ensure crop safety.

Order of addition

In general, follow the W-A-L-E-S plan when adding herbicides to a tank mix.

Add **ENVELOP** to the tank mix as the **FIRST** ingredient.

1. Wettable Powders (WP) then Flowables (F, DF)
2. Agitate then add adjuvants such as anti-foaming compounds and/or buffers
3. Liquid and Soluble products
4. Emulsifiable concentrates (EC)
5. Surfactants

Prior to mixing you should fill your spray tank with half of the carrier that you intend to use. Then start the sprayer and check to make sure that all valves and gauges work and that you have proper tank agitation.

SUGGESTED USE RATES*

Application	ENVELOP per 100 gallons liquid fertilizer
Liquid complete (N-P-K) fertilizers	3 to 4 pints
Liquid mixed (NP) fertilizers	2 to 3 pints
Liquid nitrogen fertilizers	1 to 2 pints
Wetter/buffer	1/2 to 2 pints
Pesticide incompatibility	1 to 2 pints

* Higher rates may be used to reverse incompatibilities. The rates listed in the chart are suggested but not limited.

STORAGE AND DISPOSAL

STORAGE: Store in a cool well-ventilated place. Keep in original container tightly closed. Do not reuse empty container. Do not store with food, feed, or other material to be used or consumed by humans or animals. Do not contaminate water supplies. Store between 40° and 90° F.
