#### PERSONAL PROTECTIVE FOUIPMENT

Wear chemical splash eyewear, face shield and acid impermeable gloves, longsleeve shirt and pants, rubber apron and shoes and socks.

#### FIRST AID

#### GENERAL INFORMATION

VANTAGE is a superior nonionic organosilicone surfactant engineered to efficiently wet the target and improve coverage by spreading the active ingredients throughout the canopy.

VANTAGE is compatible with most pesticides and fertilizer products.

Irrigation Injection: Applications of VANTAGE through irrigation injection systems are possible when following the recommended use rates, dilutions are maintained, and local, state and federal quidelines are followed.

#### DIRECTIONS FOR USE

Not for aquatic use.

Follow the directions on all pesticide labels.

If the pesticide does not specify the use of a nonionic surfactant, and anorganosilicone spreading and wetting agent follow the directions below. Use only if a surfactant and organosilicone spreading and wetting agent is allowed or not excluded on the label. WAVTAGE does not contain arrinonium sulfate. If the user does not have experience with the mixture being applied, perform a jast est using the order and amounts in the mixture and perform a phytotoxicity test to ensure crop safety.

#### MIXING INSTRUCTIONS.

To minimize foaming, fill spray tank ¾ full of water. If foaming is anticipated, the addition of an antifoaming agent should be added before pesticides, nutrients or VANTAGE.

While agitating, add *VANTAGE* and mix for 1 to 2 minutes with lower than normal agitation. Continue filling tank maintaining minimal agitation.

Then follow the W-A-L-E-S plan when adding the remaining ingredients to a tank mix.

- 1. Wettable Powders (WP) then Flowables (F, DF)
- 2. Agitate then add adjuvants such as anti-foaming compounds, buffers
- 3. Liquid and Soluble products
- Emulsifiable concentrates (EC)
- 5. Surfactants or other adjuvants

Prior to mixing you should fill your spray tank with half of the carrier you intend to use, usually water. Then start the sprayer and check to make sure that all valves and gauges work and that you have proper tank aditation.
