Coating on Fertilizer Blends: This product is used as a coating on all dry fertilizer blends. Application rates and timings should be based on soil and/or tissue tests, as well as recommendations from a professional agricultural consultant. Retention levels of *VitaCrop Micro* on dry fertilizer blends will vary.

Factors affecting the retention level include the quality of the dry fertilizer, the level of dust within the dry fertilizer and the presence of liquid additives.

Humic acid may aid in micronutrient uptake.

DIRECTIONS FOR USE

VitaCrop Micro is a fertilizer designed to aid in crop establishment and plant growth.

As a general guideline, the retention rates of *VitaCrop Micro* on many common dry fertilizer blends range from 0.3 to 1.0% by weight. Liquid additives may increase the retention of *VitaCrop Micro*.

To determine the coating capacity of *VitaCrop Micro* on your dry fertilizer blends, always use a blend test. For additional information, consult with an Innvictis Crop Care representative.

Wear a dust mask and handle product in well-ventilated area.

STORAGE AND DISPOSAL

Store in a cool, dry, well ventilated location away from incompatible materials.
Store locked up.
Keep containers closed when not in use.
Protect from physical damage.
