4. FIRST AID MEASURES

5. FIREFIGHTING MEASURES

Fire and Explosion Hazards: Liquid may evaporate and form vapors (fumes) that can catch fire and burn with explosive violence. Invisible vapor spreads easily and can be ignited by sources such as pilot lights, welding equipment, electric motors and switches.

6. ACCIDENTAL RELEASE MEASURES
