Folo Spray *SUPER K 8-0-50* contains 100% soluble potash designed for injection into irrigation systems. Folo Spray *SUPER K 8-0-50* is compatible with most liquid fertilizer materials. However, a compatibility test is recommended before full scale mixing, if the desired combination has not been used in the past. When temperatures are cold allow extra time for this product to completely dissolve.

Foliar fertilization is intended as a supplement to a regular fertilization program and may not, by itself, provide all the nutrients normally required by crops or other intended plants.

The irrigation system must contain a functional check valve, vacuum relief valve and low-pressure drain appropriately located on the irrigation pipeline to prevent water source contamination from backflow.

DIRECTIONS FOR USE

IRRIGATION SYSTEMS - Solid set, Overhead drip, Sprinkler or Pivot: Dissolve Folo Spray *SUPER K 8-0-50* in the mix tank and apply in the irrigation water. For proper rates and application methods contact an agricultural crop consultant.

STORAGE & DISPOSAL

Store product in a dry place. **DO NOT** contaminate water, food or feed by storage or disposal.
