SULFEGRO AMP contains soluble micronutrients which are immediately available to the plant and which assist in the formation of chlorophyll, photosynthesis and growth in plants. It is a valuable source of iron, zinc and sulfur that provides essential micronutrients, especially those grown in alkaline soils. Caution should be taken when applying to iron and zinc deficient acidic soils. When applying to acidic soils use the lower rates.

SULFEGRO AMP contains concentrated iron, which will stain masonry and clothing. Ruststained clothing should be washed separately from other clothing. If spilled on masonry, wash with water to reduce staining. Contact a chemical consultant for specific instructions

DIRECTIONS FOR USE

SULFEGRO AMP is compatible with most granular fertilizer materials.

NUTRITIONAL MAINTENANCE

Apply 5-25 lbs. per acre. Application rates should be based upon soil test analysis and recommendations. It is recommended that *SULFEGRO AMP* be blended with fertilizers when possible.

SOIL AMENDING / CONDITIONING

Apply 25-75 lbs. per acre. Rates will vary depending upon the severity of the deficiency, climate, crop, and soil type.

STORAGE & DISPOSAL

Store product in original container tightly closed, upright, in a dry place. DO NOT contaminate water, food or feed by storage or disposal.
