FIRST AID

Call a poison control center or doctor immediately for treatment advice. Have the product container with you when calling a poison control center or doctor, or going for treatment.

IF IN EYES: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses if present, after the first 5 minutes, then continue rinsing eye.

EVICATE is an antifoam and defoaming agent designed to effectively prevent or reduce foam formation in agricultural applications of crop protection and / or fertilizer products. *EVICATE* is effective over a broad pH range and can be added before or after foam formation has begun.

DIRECTIONS FOR USE

The addition of adjuvants to some pesticides and / or fertilizers and their tank mixes may cause phytotoxicity to the foliage and / or fruit of desirable crops. Before using *EVICATE*, the applicator or crops advisor must have experience with the pesticide combination, including *Evicate*, or must have conducted a phytotoxicity test.

APPLICATION RATE RECOMMENDATIONS

Use 1 -10 ounces per 100 gallons of spray solution.

Note: Effectiveness will depend upon composition of the spray mixture, temperature, and agitation. Adjust the use rate of *EVICATE* as necessary to achieve desired level of foam control.

MIXING

In the absence of specific mixing instructions found on the pesticide label, fill the spray tank with at least 50% of the desired finished carrier volume. When premixing in a mixing vessel or inductor, fill with at least 20% of the desired finished carrier volume. While the carrier is agitating, add tank mix ingredients in the following order:

1. Compatibility agent and / or antifoam (*Evicate*), if needed
2. AMS, dry formulations (WP, DF, WDG, SP), and dry drift retardants
3. Dry soluble and suspension fertilizers / micronutrients
4. Liquid drift retardants and flowable formulations (F & FL)
5. Liquid concentrates, suspension and microencapsulated (LC, SC, ME)
6. Emulsifiable concentrates (E, EL or EC)
7. Solutions and soluble liquids (S or SL)
8. Liquid micronutrients and fertilizers
9. Water conditioners and other adjuvants (COC, HSOC, MSO, NIS)
10. Finish filling to desired spray volume level and continue agitation

STORAGE AND DISPOSAL

DO NOT contaminate water, food, or feed by storage or disposal.

STORAGE: Store product in original container only, away from other pesticides, fertilizers, food or feed. Protect product from freezing.
